# Professional Lands Management Certification Program (PLMCP)

The PLMCP was created for the purpose of recognizing the accomplishments of professionals working in First Nation lands and environment disciplines. Certification establishes professional credibility at a national level, formally recognizes and verifies skills and knowledge, and enhances marketability for a First Nation. It assures that an individual meets specific criteria, remains current in the field, and maintains a professional code of ethics. This represents both an achievement and a responsibility for the individual. First Nations operating under RLEMP are eligible to receive additional funding with a certified land manager.

Training is beneficial to First Nations regardless of land regime, as well as anyone seeking to learn more about Indigenous Land Management. Through PLMCP, Nations are able to meet the existing, emerging, and future land management responsibility to successfully manage their own lands.

## **PLMCP Level I: Post Secondary Training**

**Level I** is the post-secondary component offered at 4 universities, each providing fundamental land management, legal, and environmental foundations for First Nations Lands Managers. NALMA's University partners are:

## **PLMCP Level II: Technical Training**

A candidate who successfully completes Level I is eligible to apply for Level II: Technical Training. NALMA prioritizes applicants who are working for a First Nation.

**Level II** is the technical component that provides a deeper practical understanding of land and related subjects and applications in the effective and efficient management of Reserve Lands.

Level II is comprised of 18 credits: 15 of these credits are through mandatory Core Courses while 3 of these credits are achieved through Elective Options.
