ABOUT MACIW: The Minister of Indigenous Relations and Reconciliation created the MACIW in June 2011 to provide advice to the Government of British Columbia on how to improve the quality of life of Indigenous women across BC. Funding for the 2024-2025 Giving Voice Call for Proposals is being made available through a new Canada-British Columbia bilateral agreement as part of the National Gender-Based Violence Action Plan.
